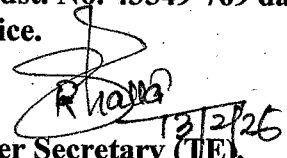

The official will not be entitled to TTA and joining time as admissible under rules.

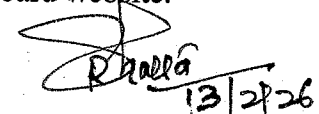
