**\*O R D E R\***

**WHEREAS**, Er. Sunil Kumar, Assistant Engineer (Electrical), was transferred from Electrical Sub-Division No. 1, HPSEBL, Hamirpur to Thiroth Power House Sub-Division, Keylong, District Lahaul & Spiti, vide transfer order dated 14.07.2026. Aggrieved by the said transfer, the petitioner preferred CWP No. 14636 of 2026, titled Er. Sunil Kumar vs. HPSEB Ltd. & Others, before the Hon'ble High Court of Himachal Pradesh, primarily on the ground that his aged father is suffering from Stage-IV lung cancer and is undergoing treatment at IGMCH, Shimla. It was submitted that immunotherapy has been commenced and the patient is required to visit the hospital regularly at intervals of approximately 21-25 days. The petitioner further submitted that the place of his transferred posting is approximately 270 KM away from his home town, thereby making it extremely difficult for him to attend to and accompany his father for the aforesaid treatment, particularly as he is the only son.

**AND WHEREAS**, the Hon'ble High Court of Himachal Pradesh, vide judgment dated 24.08.2026 passed in CWP No. 14636 of 2026, disposed of the writ petition with a direction to the Competent Authority to consider and decide the representation dated 20.07.2026 submitted by the petitioner, within a period of four weeks, in accordance with law.

**AND WHEREAS**, in compliance with the aforesaid directions of the Hon'ble High Court, the representation of Er. Sunil Kumar has been duly examined and considered with reference to the relevant records, the prevailing Transfer Policy, the circumstances pleaded by the petitioner, and the comments/views furnished by the concerned administrative authorities.

**AND WHEREAS**, it is observed from the record that the transfer of Er. Sunil Kumar from Electrical Sub-Division No. 1, Hamirpur to Thiroth Power House Sub-Division, Keylong, vide order dated 14.07.2026, had arisen consequent upon the proceedings in CWP No. 10229 of 2026 filed by Er. Karan Singh, Assistant Engineer (Electrical). Er. Karan Singh had completed the prescribed normal tenure of three summers and two winters at the tribal station of Thiroth Power House Sub-Division, Keylong. Pursuant to the directions/orders passed in the said matter, Er. Karan Singh was adjusted at Electrical Sub-Division No. 1, Hamirpur against Er. Sunil Kumar, Assistant Engineer (Electrical), resulting in the transfer of Er. Sunil Kumar to Thiroth Power House Sub-Division, Keylong vide order dated 14.07.2026.

**AND WHEREAS**, during examination of the matter, it has further been found from the available records that Er. Vijay Kumar, Assistant Engineer (Electrical), has been posted at Electrical Sub-Division, Barsar, since 04.09.2023 and has completed the prescribed normal tenure at the said station. Thus, Electrical Sub-Division, Barsar, being a station where a longer-stayee officer is presently posted, has been found to be an administratively feasible station for adjustment of Er. Sunil Kumar.

**AND WHEREAS**, the adjustment of Er. Sunil Kumar at Electrical Sub-Division, Barsar, against Er. Vijay Kumar, Assistant Engineer (Electrical), is considered administratively feasible and does not adversely affect the operational requirements of the Board. The proposed adjustment also takes into account the personal circumstances pleaded by the petitioner, the length of stay of the incumbent officer at Barsar, the prevailing Transfer Policy, and the directions of the Hon'ble High Court.

**AND WHEREAS**, upon consideration of the entire matter, including the representation dated 20.07.2026, the relevant service/transfer records, the medical circumstances cited by the petitioner, the administrative feasibility of the proposed adjustment, and the applicable Transfer Policy, the Competent Authority is satisfied that the request of Er. Sunil Kumar merits acceptance.

**NOW, THEREFORE**, in compliance with the judgment dated 24.08.2026 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 14636 of 2026, the representation dated 20.07.2026 submitted by Er. Sunil Kumar, Assistant Engineer (Electrical), is hereby **accepted and disposed of accordingly**.

Consequently, the transfer of Er. Sunil Kumar, Assistant Engineer (Electrical), from Electrical Sub-Division No. 1, HPSEBL, Hamirpur to Thiroth Power House Sub-Division, Keylong, District Lahaul & Spiti, ordered vide transfer order dated 14.07.2026, is hereby modified. Er. Sunil Kumar, Assistant Engineer (Electrical), is hereby transferred to Electrical Sub-Division, Barsar against Er. Vijay Kumar, Assistant Engineer (Electrical), on vice-versa basis, accordingly, Er. Vijay Kumar, Assistant Engineer (Electrical) is hereby transferred to Thiroth Power House Sub-Division, Keylong, District Lahaul & Spiti with immediate effect.

Both the officers shall be entitled to TTA/JT, as admissible under the applicable Rules.

The concerned authorities shall ensure compliance with the above orders forthwith.

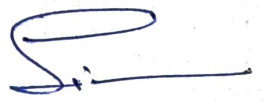
