ORDER

The complainant has instituted the above-captioned complaints before this Forum.

During the course of the proceedings, it has come to the notice of this Forum that the issues involved in the present complaints are presently pending adjudication before the Hon'ble High Court of Himachal Pradesh. It has further been brought to the notice of the Forum that the next date of hearing in the said proceedings is fixed in October, 2026.

Since the subject matter involved in the present complaints is directly and substantially under consideration before the Hon'ble High Court, the issues are sub judice. In such circumstances, this Forum is of the considered view that it would neither be appropriate nor legally expedient to adjudicate upon the present complaints at this stage, as any findings or decision rendered by this Forum may be affected by, or may run contrary to, the final adjudication of the Hon'ble High Court.

Accordingly, both the complaints are disposed of for the present without adjudicating on merits.

However, liberty is reserved in favour of the complainant to approach this Forum afresh, after the final judgment/order is rendered by the Hon'ble High Court of Himachal Pradesh, subject to the provisions of law, including limitation and maintainability, as may be applicable.
