ORDER

The case was listed for final arguments today. During the course of hearing the Ld. Counsel for the complainant submitted that on the basis of the re-calculated demand, which is also placed on record, for the period w.e.f. 01.05.2010 to 15.09.2010 and 11.10.2010 to 31.03.2011 amounting to Rs.1,75,824/-, the present complaint may be allowed to be withdrawn. The prayer of the complainant allowed.

In view of the prayer/submission of the complainant made today the present complaint is dismissed as withdrawn, in terms of the aforesaid submissions and the consent of the parties. The complainant is directed to deposit the said demand of Rs. 1,75,824/- as agreed to, within a period of two weeks' time from today. Respondent HPSEBL, to intimate compliance to the Forum. In case of failure to deposit the amount of demand referred above by complainant within a stipulated period, in that eventuality the Respondent Board shall be at liberty to take appropriate action, as required under regulations against the complainant to effect recoveries etc. In the aforesaid terms the complaint stands disposed of. The parties are left to bear their own cost.
