OFFICE ORDER

Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Limited Pensioners/Family Pensioners – Revised rate effective from 01.01.2022.

In continuation to this Office Notification endorsement No. HPSEB (SECTT)/ R&E/6-155/2022-18819-19069 dated 30.05.2022, the Himachal Pradesh State Electricity Board Ltd. is pleased to decide that dearness relief payable to the HPSEBL pensioners/family pensioners shall be enhanced from existing rate of 31% to 34% w.e.f. 01.01.2022 to the HPSEBL Pensioners/Family Pensioners.

1. The dearness relief may be released after adjusting the extra amount, if any, paid to pensioners in cases where the total unrevised pension exceeded revised pension, if still unadjusted, as brought out in para 8 of the OM of even number dated 25-02-2022.
2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the nearest rupee.
3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
4. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority (PDA), including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
5. The additional dearness relief shall be paid with the pension/ family pension for the month of **May, 2023** payable in the month of **June, 2023**. The arrears accrued on account of dearness relief w.e.f. **01.01.2022** to **30.04.2023** shall be paid in one installment.
