"ORDER"

In Compliance to the orders /directions issued by the Id. HPERC contained in letter bearing No. HPERC-H(1)-12/2019 -2985 dated 06.02.2021 read with letter bearing No. HPERC-H004/2/2021-AD-Tech-GoHP-15679/2021 dated 06.03.2021, the HPSEBL is pleased to decide as under:-

1. That all the Superintending Engineer(s) in Operation Circles of the HPSEBL in the State of Himachal Pradesh are appointed/designated as Nodal Officers who will ascertain/monitor the implementation of the orders passed by the Id. CGRF as also by the Id. Electricity Ombudsman and also ensure regular submission of the compliance / latest status reports in future on the prescribed format to the Id. Commission.
2. That whenever an order passed by the Id. CGRF/Ombudsman is received by the concerned Superintending Engineers being the Nodal Officer in respect of the cases arising out of and pertaining to his jurisdiction shall be examined and processed within a period of one week for getting it examined from the office of Chief Engineer (Comm.) with reference to the operative regulations by dealing a responsible officer/official well conversant with the facts of the case together with the entire connected records of the case.
3. The office of Chief Engineer (Comm.) will examined with the matter within a period of 2 days and further forward the entire case together his recommendations in the matter to the Legal Cell of the Board for its further examination.
4. That the Legal Cell of HPSEBL will further examine and process the matter with reference to the provisions of operative regulations as also the law within a period of one week for the purpose of

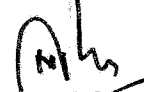
