"ORDER"

WHEREAS, Sh. Ishwar Dass, Sr. Assistant, presently posted in the Electrical Sub-Division, HPSEBL, Kasauli under Electrical Division, HPSEBL, Parwanoo, was transferred to the Electrical Sub-Division, HPSEBL, Parwanoo under the same Division *vice* Sh. Rupender Kumar, Sr. Assistant, vide speaking order No. HPSEBL (Sectt.)/NGE/6-114/2025-41743-53 dated 03.09.2025.

AND WHEREAS, the said official did not assume charge at his new place of posting and has submitted a representation dated 15.09.2025 (received through letter dated 22.09.2025) requesting adjustment in the Electrical Sub-Division, HPSEBL, Dharampur under Electrical Division, HPSEBL, Parwanoo, against a vacant post.

NOW, THEREFORE, the competent authority of HPSEBL has examined the matter and proceeds to dispose of the representation as under:-

1. The applicant has stated that he is a permanent resident of Village Kamli, P.O. Parwanoo, Tehsil Kasauli, District Solan, and is the sole earning member of his family consisting of his aged mother, wife, and children, all of whom are dependent upon him. He has further asserted that his mother, who is suffering from multiple ailments including respiratory issues, had to shift from Parwanoo due to industrial pollution and has since been residing with him at Kasauli, where the climatic conditions are more conducive to her health. It has also been represented that his wife recently underwent surgery for gallbladder stones and is not in a position to look after his mother. His brother having passed away in 2017, the applicant alone bears family responsibilities. The applicant has further contended

that his posting at Parwanoo, being his permanent residential area, may give rise to unwarranted approaches and false allegations, which could cause undue hardship and harassment. He has also mentioned that he has been allotted official accommodation at Kasauli and seeks permission to continue the same due to the unsafe condition of his private house caused by heavy rainfall, landslides, and seepage. The said accommodation is approximately 7-8 km from Electrical Sub-Division, Dharampur, which would be suitable and convenient for him in case of posting there. Supporting photographs have been enclosed with his representation. Accordingly, he has requested that the transfer order dated 03.09.2025 be reconsidered and he be adjusted at Electrical Sub-Division, Dharampur against the existing vacancy.

2. The representative of the concerned Administrative Section was also heard and it was stated by him that one post of Sr. Assistant is presently lying vacant in Electrical Sub-Division, HPSEBL, Dharampur under Electrical Division, HPSEBL, Parwanoo and the official herein can be suitably adjusted in that Electrical Division.

In view of the facts and circumstances explained above, and after careful consideration of the applicant's representation, Sh. Ishwar Dass, Sr. Assistant, is transferred and adjusted in the Electrical Sub-Division, HPSEBL, Dharampur under Electrical Division, HPSEBL, Parwanoo, against the existing vacancy.

However, it is ordered that the official shall not be entitled to any Transfer Travelling Allowance (TTA) or joining time, as this adjustment is being made purely on his own request.
