“ORDER”

WHEREAS the Petitioner namely Sh. Sewak Ram S/o Late Sh. Nokhu Ram, R/o Village & Post Office Barsu, Tehsil Balh, Distt. Mandi, HP who was working as Sr. Assistant in the O/o Chief Engineer (Gen.) HPSEBL, Sundernagar District Mandi H.P had filed CWP No. 2516 of 2025 before the Hon’ble High Court of HP at Shimla, praying therein for the following reliefs:

- “a) That writ in the nature of certiorari may kindly be issued and impugned transfer order (Annexure-P-1) dated 06.02.2025 may kindly be quashed and set aside qua petitioner.
- b) That writ in the nature of Mandamus may kindly be issued directing the Respondents to allow the Petitioner to work as a Sr. Assistant in the office of Chief Engineer (Gen.) Himachal Pradesh State Electricity Board Limited, Sundernagar, Distt. Mandi HP etc.etc.”

AND WHEREAS the Writ Petition aforesaid came up for hearing before the Hon’ble High Court of HP at Shimla on 21.02.2025 when the Hon’ble Court of HP was pleased to pass the following directions as under:

“Accordingly the operation of impugned order dated 06.02.2025 (Annexure-P-1) transferring the petitioner as

Sr. Assistant from O/O Chief Engineer (Gen) HPSEB Ltd. Sundernagar to O/O F&A Wing HPSEBL Shimla shall remain stayed, qua the petitioner, till the next date of hearing.

List the matter, before appropriate Bench, on 18.03.2025"

AND WHEREAS the Writ Petition aforesaid again came up for hearing before the Hon'ble High Court of HP at Shimla on 18.03.2025 when on the basis of instructions filed in the matter CWP No. 2270 of 2025, the Hon'ble Court has been pleased to pass the following orders /directions:

Reply is stated to have been filed.

"Learned counsel for the Respondents submits that in view of instructions dated 06.03.2025, which were placed on record of CWP No. 2270 of 2025, the respondents, HPSEBL is willing to consider the case of the petitioner for his adjustment as per these instructions.

Let the petitioner submit representation to respondent No.1 within two days, whereafter, the same be examined by respondent No.2/Competent Authority within a week.

List this matter on 22.03.2025 when fresh status report shall be filed by the respondents.

Interim orders to continue till next date of hearing."

AND WHEREAS the petitioner was under a direction to submit the representation vide order dated 18.03.2025 but the Petitioner had not tendered any representation in pursuance of the aforesaid orders/directions passed by the Hon'ble High Court of HP at Shimla in his writ petition.

AND WHEREAS the Writ Petition aforesaid again came up for hearing before the Hon'ble High Court of HP at Shimla on 22.03.2025 when the Hon'ble Court has been pleased to pass the following orders /directions:-

“Learned counsel for the respondents states that the representation of the petitioner has not been received by them as yet.

Learned counsel for the petitioner submits that the petitioner had represented through proper channel within the time indicated in the previous order.

 Hence, list the matter after ten days in terms of order dated 18.03.2025.

Interim order to continue till the next date”.

AND WHEREAS the Petitioner had tendered his representation in pursuance of the aforesaid orders/directions dated 18.03.2025 passed by the Hon'ble High Court of HP at Shimla in his writ petition. The representation of the petitioner was considered by the competent authority and decided by passing a well reasoned speaking order

dated 11.04.2025. The said order as also placed on records before the Hon'ble High Court of HP for its kind consideration.

AND WHEREAS the Writ Petition aforesaid again came up for hearing before the Hon'ble High Court of HP at Shimla on 23.06.2026 and Hon'ble Court was pleased to pass the following directions as under:-

2. The petitioner is aggrieved by transfer order dated 6.2.2025 (Annexure P-1) in terms whereof, the petitioner was ordered to be transferred from Sundernagar to Shimla.

3. A perusal of the petition demonstrates that the petitioner was posted at Sundernagar on 20.4.2022. The operation of the impugned transfer order was stayed by this Court on 21.2.2025, however, in light of the fact that now the petitioner has completed his normal tenure i.e. more than 3 years at the said station, this petition is dismissed. Interim vacated.

4. At this stage, learned counsel for the petitioner submits that as the petitioner is to retire within two years, he be granted liberty to approach the authority for his adjustment at a convenient station. Prayer being innocuous is allowed.

With the said observation, the instant petition is disposed of, so also pending miscellaneous applications, if any".

AND WHEREAS the petitioner has submitted his representation in pursuance of the aforesaid orders dated 23.03.2026 passed by the Hon'ble High Court of H.P at Shimla.

As such keeping in view the averments made by the petitioner in his representation as well as the orders dated 23.06.2026 passed by the Hon'ble High Court of H.P in CWP No.2516 of 2025, the competent authority proceeds to decide the representations of the Petitioner as follows:

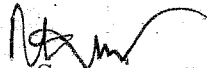
1. That petitioner has asserted that he was transferred during the rationalization of staff in the Generation Wing on 06.02.2025 from the O/o Chief Engineer (Gen.) HPSEBL, Sundernagar to F&A Wing HPSEBL, Shimla. Aggrieved by his transfer order he had filed a writ petition before the Hon'ble High Court, considering that he is due to retirement on 30.06.2027. He has further stated that the Hon'ble Court had stayed the operation of transfer order in CWP No.2516 of 2025. Subsequently, the Hon'ble High Court was pleased to grant him liberty to approach the competent authority for his adjustment/posting at a convenient station, considering that he is due to retire on 30.06.2027. He has further stated that it is extremely difficult for him to join at Shimla as his 92 years old mother is bedridden due to her advanced age and deteriorating health and she is entirely dependent upon him for her day-to-day care and assistance, there is no other family member available to look after her in his absence. In these circumstances, his posting at Shimla would cause him and his family hardship. Keeping in view of this, he has requested that he may kindly be adjusted in Elect. Division, HPSEBL, Mandi HP.

2. That the representative of the concerned administrative section was also heard and it was stated by him that keeping in view the directions dated 23.06.2026 passed by the Hon'ble High Court of HP as well as the averments made by the petitioner in his representation, the petitioner can be suitably adjusted at Electrical Division, HPSEB Ltd., Mandi HP since one post of Senior Assistant is lying vacant there.



Keeping in view the facts and circumstances of the case at hand, as well as the orders issued by the Hon'ble High Court of Himachal Pradesh dated 23.06.2026 in CWP No.2516 of 2025, the request of the petitioner has been duly considered. Accordingly, the petitioner who is under order of transfer from O/o Chief Engineer (Gen.) HPSEBL, Sundernagar to F&A Wing HPSEBL, Shimla is hereby ordered to be adjusted and posted in Electrical Division, HPSEB Ltd., Mandi against vacant post. He shall not be entitled to TTA/JT. The representation of the petitioner is disposed of accordingly.

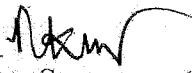
