Matter was listed today for admission hearing. Authorized Representative appearing on behalf of Complainant submits that the matter is of late implementation of applied contract demand against which demand notice of Rs. 15,13,400/- has been raised by the Respondent.

It is seen from record that the advance copy of complaint has been forwarded to the Respondent. In the matter Application has also been filed under Regulation 25 of the HPERC (CGRF and Ombudsman) Regulations, 2013 by Complainant for relief against operation and execution of demand notice dated 27.06.2023 for Rs.15,13,400/- and against disconnection of supply.

The Complainant also informs that as on date, the amount has not been billed. However, the complainant submits that it is willing to deposit 1/3<sup>rd</sup>

amount of Rs.15,13,400/- as provided under regulation 25 of HPERC (CGRF and Ombudsman) Regulation,2013 amounting to Rs.5,04,467/-

Complaint is admitted.

On perusal of record, The Forum does not find the disputed amount to have been raised in the electricity bills of the Complainant and neither has any notice been issued under section 56 of the Electricity Act 2003.

The Forum does not see any immediate threat of disconnection. It is merely an apprehension on part of complaint. However, in view of the prayer ibid, Complainant is directed to deposit the aforesaid 1/3<sup>rd</sup> amount of Rs.5,04,467/- with the Respondent within a period of 10 days from today i.e. on or before 15.09.2023.

On deposit of the said 1/3<sup>rd</sup> amount by Complainant on or before 15.09.2023, the Respondent shall not insist for deposit of the disputed amount and shall not take any coercive action.

On failure of Complainant to deposit the said 1/3<sup>rd</sup> amount, the Respondent shall be at liberty to take action as per extant Regulations.

On deposit of the said amount, the Complainant shall place on record copy of the receipt of payment.

On aforesaid terms, the Application is disposed.

Main complaint to come up for Reply by Respondent. Respondent is directed to file the Reply in main complaint on or before 27.09.2023.
