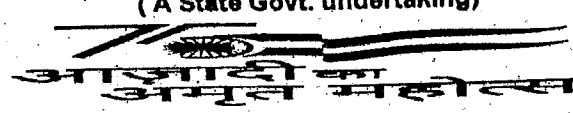

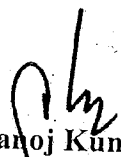

9. He will have to take oath and undertaking in writing that he will not leak-out any official information.

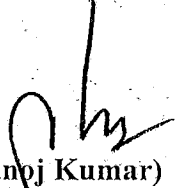
