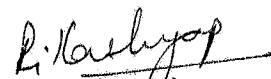
**Subject:- Non receipt of outstanding amount to the tune of Rs. 14.58
Crore in respect of I&PH department (now Jal Shakti Vibhag)**

Er. Rajeev Kumar ji,

I would like to draw your kind attention towards the amount of Rs. 14,58,68,543/- (Fourteen crore fifty eight lac sixty eight thousand five hundred forty three) which is lying outstanding on account of energy charges with I & PH department (now Jal Shakti Vibhag) ending 31.12.2021. It is also to point out that due to non-recovery of the outstanding dues the liability of HPSEB Ltd. is being increasing day by day from various consumers whereas HPSEB Ltd is paying surcharge on delayed payments on account of Purchase of Power @18% Per annum. The HP State Electricity Board Ltd being a commercial organization cannot afford such long time pendency of unrealized amount from any consumers.

This, being a revenue matter therefore may kindly be assigned TOP priority. Moreover, you are directed to take up the matter with concerned officers of Jal Shakti Vibhag by personally visiting or deputing responsible officer in the office of Jal Shakti Vibhag immediately and request them to pay/clear the outstanding amount electricity charges of HPSEB Ltd at the earliest please. Progress in the matter may also be intimated before 20th February 2022.

This may be treated as very urgent.
