1. 2. The Character & Antecedent Report of above named official is to be got verified by Controlling officers from the concerned competent authority within the period as required under rules.
3. The seniority of the above mentioned officials will be fixed in the respective cadre on the basis of selection merit of HPSC. However, the entitlement of leave(s) etc. under CCS (Leave) Rules shall accrue to the officials from the date of issue of these orders.
4. The contractual appointee who are regularized shall be liable to be posted anywhere in the State.
5. Necessary entry to this effect is required to be recorded in the service book of concerned officials.
6. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
7. Their appointment will be subject to the production of Medical Certificate of fitness from the Medical Officer of the Government Hospital.
8. They have to give a declaration that they have got only one living wife/husband or is a bachelor.
9. They will have to take oath and undertaking in writing that he/she will not leak-out any official information.
