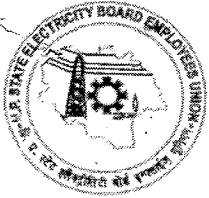

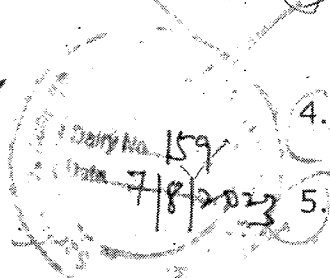
1. To implement old pension scheme in HPSEBL without further delay. (Committee)
2. To give immediate halt on transfer of HPSEBL Project, Transmission & Generation wing assets to other power utilities. Further to withdraw the orders of 4 small HEP of HPSEBL proposed to transfer to HPPCL.
3. To implement the decision taken in the service committee held on 20th May, 2023 so that posts of ALM, SSA etc. could be filled up in HPSEBL.
4. To review the decision taken with regard to 100% smart metering in HPSEBL in view of its demerits.
5. To hold a meeting with the union on various demands related to regular as well as outsource establishments of HPSEBL at the earliest.
