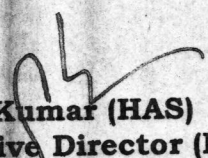

- 3 EPF registration number

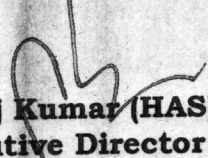
