Complaint has been filed before the Forum by M/s Varav Biogenesis Pvt. Ltd.
Complaint is accompanied with Application for Ad-Interim- Ex-Parte stay.

In the matter Forum observes that on July 30,2024, Hon'ble High Court of Himachal Pradesh has passed Judgment/Orders in CWP 7466 of 2024 titled M/s Varav Biogenesis Pvt. Ltd. Vs HPSEB & Anr. where-in impugned Demand Notice dated 16.03.2024, monthly energy bill dated 01.06.2024, for demand of Rs. 12,67,038/-has been stayed for a period of four week.

In the ibid Judgment/Orders passed by the Hon'ble Court on 30.07.2024, Hon'ble Court has also directed Respondent HPSEBL not to implement the temporary disconnection notice dated 22.07.2024, for a period of four week

The Hon'ble Court has disposed of the said writ petition along with the Miscellaneous Application.

Complaint is admitted.

In view of the Judgment/Orders ibid passed by the Hon'ble Court on 30.07.2024, in the said CWP filed by the petitioner/ Complainant herein, the Forum Orders that the Stay granted

by the Hon'ble Court on July 30.2024, shall also continue to be operative beyond the period of four weeks granted by the Hon'ble High Court, till further Orders and subject to deposit of $\frac{1}{3}^{\text{rd}}$ of Rs. 12,64,038/- amounting to Rs. 4,21,346/- within a period of ten(10) days, in accordance with regulation 25 of the HPERC(CGRF & Ombudsman) Regulations, 2013.

The direction given by the Hon'ble Court to the Respondent not to implement temporary disconnection Order dated 22.07.2024, for a period of four weeks, shall also continue to be operative beyond the period of four weeks till further Orders and subject to deposit of said $\frac{1}{3}^{\text{rd}}$ amount.

On the next date of hearing, the Complainant is directed to place on record copy of proof of deposit of the said $\frac{1}{3}^{\text{rd}}$ amount of Rs. 4,21,346/-.

In the event of non deposit of the $\frac{1}{3}^{\text{rd}}$ amount of Rs. 4,21,346/- within the specified period of ten days, the Ad-Interim- Ex-Parte stay granted herein, shall automatically stand vacated and Respondent shall be at liberty to take action as per extant Rules/Regulations governing the matter.

Miscellaneous Application is accordingly disposed of on aforesaid terms.
