NOTIFICATION

In continuation of this department's notification of even number dated 5th October, 2016, the Governor, Himachal Pradesh is pleased to incorporate the para 3.6 under Chapter III of the Mukhya Mantri Bal Uddhar Yojana-2016, with immediate effect, as under:-

3.6 Scholarships:- Scholarships amounting to Rs. 10,000/- each will be provided every year under Mukhya Mantri Bal Uddhar Yojana, to 10 boys and 10 girls of Child Care Institutions registered & funded under Juvenile Justice (Care and Protection of Children) Act, 2015, who will secure top 2 positions in the merit list (separate for boys and girls) of children of Child Care Institutions in Annual Examination of 8th, 9th, 10th, 10+1 and 10+2 Examination. Names of two boys and two girls, securing top positions in each class from 8th to 10+2 shall be conveyed by the District Child Protection Officer to the Director, Women and Child Development by 31st July, every year. Merit List will be finalized at the Directorate level by a Committee to be constituted for this purpose. In case, the two candidates hold the top positions jointly, scholarship will be awarded to both. The Director, Women and Child Development shall be the competent authority to sanction the same.
