“ORDER”

WHEREAS, the petitioner, namely Harish Kumar, son of Sh. Ramesh Kumar, resident of Village Kalthar, P.O. Bahnru, Tehsil Baldwara, District Mandi, Himachal Pradesh, is presently posted as Assistant Engineer (Electrical) in Resident Engineer, Bhaba Power House Division HPSEBL, Bhabanagar a tribal station. He joined the said office on contract basis on 4.10.2023 and has been serving there continuously since then. Subsequently, his services were regularized at the same place of posting.

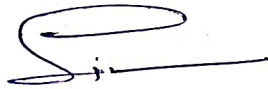
AND WHEREAS, the petitioner submitted a representation, which was received a requesting his transfer to a station nearer to his native place due to his domestic circumstances & family responsibilities. However, before any decision could be taken on his representation, the petitioner filed a writ petition before the High Court of Himachal Pradesh, being CWP No. 10771 of 2026 titled Harish Kumar vs. State of HP & others.

AND WHEREAS, the High Court of Himachal Pradesh vide judgment dated 2.7.2026 passed in CWP No. 10771 of 2026 titled Harish Kumar v/s State of HP & others. disposed of the writ petition with a direction to the competent authority to consider and decide the representation submitted by the petitioner within a period of eight weeks from the date of the judgment by passing speaking order. The operative part of the judgment is reproduced below:

“2. As prayed for this writ petition is disposed of with the direction that the representation Annexure P-2 filed by the petitioner be decided by the Competent Authority within a period of 8 weeks from today in terms of the contents therein. Pending applications, if any, also stand disposed of.”

AND WHEREAS, in compliance with the directions issued by the Hon'ble High Court of Himachal Pradesh, the representation dated 13.4.2026 submitted by Er. Harish Kumar, AE(E), received, has been examined and considered in detail in accordance with the applicable transfer policy, administrative exigencies, service requirements, and the facts and circumstances of the case. In the said representation, Er. Harish Kumar, requested his transfer after completion of tenure at tribal area to a station nearer to his native place on account of being old aged parents and sought consideration for posting at any of the following stations:

1. ESD, Sarkaghat
2. ESD, Baggi
3. ESD Rewalsar
4. ESD, Salapar
5. ESD, Sundernagar



In view of the above, the service particulars of the officers presently working in the aforesaid offices are given as under:

The feasibility of the requested stations was assessed and the following position emerged:

- Transfer to ESD, Sarkaghat has not been found feasible .
- Transfer to ESD Baggi, has not been found feasible due to the short stay of the present incumbent.
- Transfer to ESD Rewalsar has not been found feasible he completed 55 years as transfer police.
- Transfer to ESD Salapar has been found administratively feasible on a vice-versa basis.
- Transfer to ESD Sundernagar Jogindernagar has not been found feasible already proposed on separate file.

The service particulars and posting profile of Er. Manish Kumar, Assistant Engineer (Electrical), presently posted at ESD Slapper, have also been examined. Er. Manish Kumar has been serving at ESD Slapper since 24.2.2022 and is available for adjustment against the vacancy that would arise at RE, Bhaba Power House Division, Bhabanagar.



AND WHEREAS, the representation dated 13.4.2026 submitted by Er. Manish Kumar, AE(E), has been examined carefully in light of the facts and circumstances of the case, the grounds mentioned therein, his service record, the availability of suitable vacancies, the administrative requirements of HPSEBL, and the directions issued by the Hon'ble High Court of Himachal Pradesh in CWP No. 10771 of 2026.

AND WHEREAS, after due consideration of all relevant aspects, it has been found that the request of Er. Harish Kumar, for transfer after completion of tenure at tribal area nearer to his native place can be accommodated only at ESD Slapper under Electrical Division, Sundernagar through a vice-versa transfer arrangement with Er. Manish Kumar, AE(E).

NOW, THEREFORE, in compliance with the judgment dated 2.7.2026 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 10771 of 2026 and after due consideration of the representation dated 13.4.2026 submitted by Er. Harish Kumar, AE(E), the competent authority is pleased to order the transfer of Er. Harish Kumar, AE(E), from Resident Engineer Power House Division Bhabanagar to ESD Slapper under Electrical Division, Sundernagar vice Er. Manish Kumar, AE(E), and simultaneously transfer Er. Manish Kumar, AE(E), from ESD Slapper under Electrical Division, Sundernagar to Resident Engineer Power House Division Bhabanagar, on a vice-versa basis. Er. Manish Kumar, shall be entitled to usual TTA & joining time as admissible under rules.

Accordingly, the representation is disposed of accordingly in compliance with the judgment dated 2.7.2026 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 10771 of 2026.
