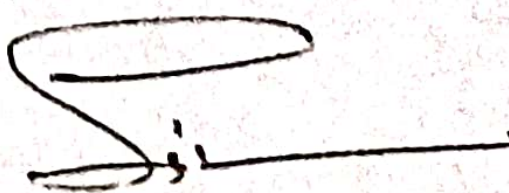

In the event of refusal by the borrowing department to make such contributions, the individual employee concerned shall be personally responsible for remitting the same. Failure to receive the required contributions from either the borrowing department or the individual employee will render the employee ineligible for pension and other retiral benefits for the period of deputation/secondment from HPSEB Limited.
