## **ORDER**

The case called Authorized Representative of the Respondent Board Assistant Engineer Nalagarh submitted that the demand notice dated 04.06.2021 issued to the complainant has been withdrawn vide order dated 04.10.2021 of the Assistant Engineer Electrical Sub-Division No.1 Nalagarh on technical grounds, after obtaining approval of competent authority. The copy of the said order dated 04.10.2021 has been submitted to this Forum today which is placed on record. Since the grievance pertained to the notices Annexre-C-1 of the complaint, which now stood withdrawn by the Respondent Board. Therefore, nothing survives in the complaint to be adjudicated upon. The Respondent Board also clarified in the withdrawal notice dated 04.10.2021 that the amount charged through sundry shall be refunded through energy bill for the month of October 2021. Accordingly Board is directed to refund the amount of the demand notice by way of adjustment in the future energy bills of the consumer if not done so far. In view of the withdrawal of the demand notice dated 04.06.2021 by the Respondent Board, the present complaint is disposed off in the aforesaid terms.
