Subject - Policy for providing 'Compassionate Employment' and delegation of Powers to department (s) for disposal of cases of compassionate appointments.

Sir,

I am directed to refer this office endst. No. HPSEBL (Sectt) R&E /14-2 (EAS)/2019-18956-19136 Dated 3/7/2019 vide which policy for providing employment on compassionate grounds notified by the Government of Himachal Pradesh vide OM dated 07.03.2019 has also been adopted by the HPSEBL. Now Principal Secretary (Finance) to the Government of Himachal Pradesh, Shimla, vide office memorandum No. Fin-F-(F)-1-1/2025 Dated 08.10.2025 has issued revised policy for providing 'Compassionate Employment' and also issued delegation of powers to departments for disposal of the employment cases on compassionate grounds. The HPSEB Ltd., has also adopted the same policy vide office order bearing No. HPSEBL (Sectt)/R&E/14-2 (EAS) 2025-69272-492 Dated 09.12.2025.

Keeping in view of above, it is intimated that at present, various cases are lying pending for employment under Compassionate Employment Policy pertaining to different offices for Class-III / Class-IV posts in HPSEBL. Since the Government of HP vide Office Memorandum referred as above has decided to provide employment under compassionate employment policy and also relaxed the 5% Direct Recruitment quota as one time measure till 31.12.2025 and also relaxation of the provision of Para-9 of the Rules of Business of the Government of Himachal Pradesh 1971 and the Finance Department's instructions dated 24.11.2018. Therefore, whose cases are lying pending for decision before the HPSEBL, as per (Annexure-A List of cases), they are requested to submit the following latest documents of the employment case to this office through concerned field offices, on and before 20.12.2025 till 5:00 PM without fail, so that the employment cases on compassionate grounds could be finalized/ decided within stipulated period.

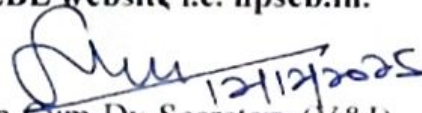
It is further requested all the Chief Engineers to obtain/ willingness from individual concerned (on the consent/ willing Performa enclosed from the as per list of

(Annexure-A List of cases) whether they are willing to accept an offer of appointment Class-III as "Job Trainee" and Class-IV (Technical/Non-Technical) as "Multi Task Workers" as per Government policy on compassionate grounds.

1. Latest Income Certificate issued by the competent authority i.e. Income of Pension and other sources.
2. Employment/Non-Employment Certificate in favour of Head of the family issued by the competent authority, whether any other legal heirs /dependent of the deceased employee, is employed in Government/ Semi Govt. job during the date of application for appointment on compassionate grounds till date.
3. Legal heir certificate/ Himachali Bonafide Certificate, SC/ST/OBC category certificate.
4. Latest copy of the Nakal pariwar registers of the family of the deceased.
5. Latest marital status of the daughters of the deceased employee, if any who is appearing in the legal heirs certificates.
6. Latest Character Certificate of the applicant.
7. Latest revised photo copy of the Family Pension Pay order issued in favour of dependent of the deceased employee.

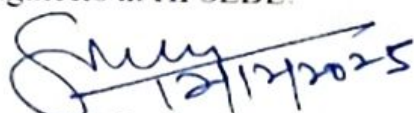

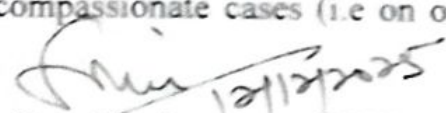
