**\*OFFICE ORDER\***

1. That they will be entitled to contributory Pension Scheme notified by the H.P. Govt. Finance departments, Vide Notification No. Fin. (Pen.) (A) (3) 01/96 dated 15.05.2003 and further adopted in the Board Ltd,
2. The regularization will be strictly on the basis of seniority subject to the condition that eligible criteria etc. prescribed in the recruitment and promotion rules for the post have been observed at the time of their initial recruitment on contract.
3. The Candidate should be medically fit for the post against which he/she is being considered for regularization. Obtaining the Medical fitness certificate of the candidate shall be ensured in accordance with the provisions contained in FR 10 and Sr 4(1), 4(2) and 4(3). That they will have to produce a medical fitness certificate from the Medical Officer of HP. Govt. Hospital.

4. The regularization shall be subject to verification of character and antecedents of the candidate being considered for regularization as provided in the H.P Financial Rules.
5. For the determination of date of birth of the candidate concerned, the criteria as laid down in Rules 172 of the H.P. Financial Rule, 2009 shall be observed.
6. A Screening Committee Shall be constituted in the cadre controlling concerned for regularization.
7. The contractual appointees who are to be regularized shall be appointed at the minimum of the time scale of the post.
8. The contractual appointees who are regularized shall be liable to be posted anywhere in HPSEBL in the interest of Board's Ltd. work by retaining their seniority in the present Division/Circle.
9. The regularization will be with prospective effect i.e from the date of issue of regularization order w.e.f 01.10.2020.
10. That they will be governed by Group Saving Linked Insurance Corporation of India as introduced in the Board Ltd.,
11. That their regularization is subject to the verification of their Character and antecedents report.
12. That their service conditions will be governed by the HPSEBL Rules/Regularization framed there under from time to time.
13. That their Seniority will be determined according to the rules of HPSEBL.
14. That their pay will be determined according to the rules of the HPSEBL.
15. That on their regularization, they will not claim the benefits of pay fixation, seniority etc. of previous service rendered on contact basis.
16. That, if the incumbent has put resignation from the service of the HPSEBL, their resignation order will be accepted by the respective offices/cadre controlling authority. (A specimen copy is sent herewith).
