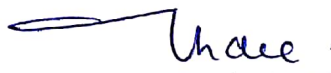

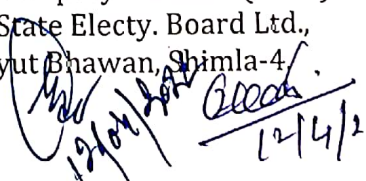

TERMS AND CONDITIONS:-

1. He/ She is required to produce his/her original Matric qualification certificate to the concerned officer before joining the post in proof of his/her qualification and age.
2. He/She is required to produce original certificate from the competent authority to the effect that he/she belongs to the Scheduled caste/Scheduled Tribe/Backward Class community to the officer concerned before joining the post, if he/she belongs to such category.
3. He/She is required to produce the latest Non-Employment Certificate, Character Certificate and Himachali Bonafide certificate duly issued by the competent authority.

4. He/She will be liable to be transferred/posted anywhere in the exigencies of Board work, wherever there services are required.
5. He/She will have to furnish declaration in writing that he/she has not been dismissed from any institution/organization under the State Govt./Government of India.
6. He/She will have to take an oath and furnish an undertaking in writing that he/She will not leak out any official information and shall be liable to punished under the relevant rule.
7. He/She will have to produce a Medical Certificate of fitness duly signed by authorized dignitaries i.e. Chief Medical Officer/Medical Officer of the Government indicating he/she is not suffering from any communicable disease.
8. He/She will have to produce a Character certificate duly issued by the competent authority/ Gazetted Officer.
9. His/ Her seniority in the Grade will be assigned later-on in accordance with the relevant rules/instructions.
10. In case he/she is married he/she shall have to furnish an undertaking in black & white that he and she has only one living spouse.
11. He/She are required to take an oath/affirm that he/she have faith and bear true allegiance to the Constitution of India as per law that he/she shall carry out their office duties with loyalty, honesty and with impartiality.

In case he/she is willing to accept this offer on the terms and conditions indicated hereas above, he/she can report for duty in the respective offices of their posting **within 30 days** from the date of issuance of this offer failing which the offer of appointment shall automatically be cancelled/withdrawn and the candidate will have no right to claim for the same.

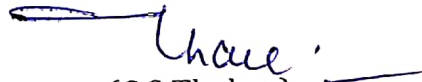
