Sir,

I, Adv. S. Partha Swami, was appointed as the Standing Counsel for the Himachal Pradesh State Electricity Board Limited (HPSEBL), Palampur Division, to represent the Board before the Hon'ble District Court of Kangra at Dharamshala, the Hon'ble ACJM Court at Palampur, and the Hon'ble District Consumer Forum of Kangra, vide **Office Order No. 106 HPSEBL/Sectt./LS/Appointment of Counsel/2025** dated 21st March 2025, issued pursuant to **Notification No. LLR-E-(9)-2/2022 dated Shimla-2, 5th March 2025**.

However, due to the lack of proper coordination and the wholly unprofessional conduct of the XEN office at Palampur, coupled with an increasing volume of cases at the Hon'ble High Court of Himachal Pradesh, where I primarily practice, I find it increasingly difficult to effectively discharge the responsibilities associated with this assignment.

Accordingly, I hereby tender my withdrawal from the aforementioned appointment as Standing Counsel for HPSEBL, Palampur Division, with immediate effect.
