NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 30th October, 2021 (Saturday) as a "Gazetted Holiday" only in the areas of 02-Mandi Parliamentary Constituency and 8-Fatehpur, 50-Arki & 65-Jubbhal-Kotkhai Assembly Constituencies (H.P.) as well as in the areas of Himachal Pradesh bordering with the aforesaid Parliamentary & Assembly Constituencies (in case poll is held) on account of Bye-Election to above Parliamentary & Assembly Constituencies of H.P. to enable the employees working in all such Government Offices, Boards Corporations, Educational Institutions and Industrial Establishments situated in Himachal Pradesh to exercise their right of franchise. This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave/ special paid holiday may be given to those employees who are working in different places in the State but have a right to vote in above Parliamentary & Assembly Constituencies, H.P. (where the election are scheduled to be held) on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.

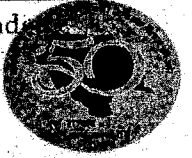
