“ OFFICE ORDER ”

Whereas, considering the recent surge in COVID-19 cases across the State and after considering the current situation of the COVID-19 pandemic which requires strict measures in order to contain its spread. The movement of public at large to bare minimum Government of Himachal Pradesh Revenue Department-Disaster Management Cell vide his order No.Rev.(DMC)©20-2/2021-COVID-19-III dated 5th May ,2021. As per these guidelines there shall be a “Corona curfew “from 6 AM of 7th May, 2021 to 6 AM of 17th May, 2021. Government & Private Offices/establishments shall remain closed. Government employees will work from home and shall not leave their headquarters without permission.

Whereas in Himachal Pradesh, H.P. State Electricity Board Ltd. is entrusted with the responsibility of supplying the electricity being an essential service. Distribution of Electricity is maintained by the offices under Chief Engineer Operation North, South, and Central Zones. Its generation is maintained by the offices under Chief Engineer (Generation). Its transmission offices within their jurisdiction is maintained by the Chief Engineer(Electrical System) and Chief Engineer(System Operation). For effective monitoring the management of HPSEBL alongwith Chief Engineer P&M shall remain in the office with bare minimum staff. The officers /officials whose offices are closed are advised to remain in the Station and shall be available in case of any exigency. The officers are also requested to ensure all the preventative measure needed to sop this pandemic disease. The order is issued after approval of the competently authority and needed its strict compliance in public interest. **The guidelines issued by the Government of Himachal Pradesh Revenue Department-Disaster Management Cell vide Office order No.Rev.(DMC)©20-2/2021-COVID-19-III dated 5th May ,2021 (copy enclosed) the instruction/guidelines be followed strictly in the letter and spirit.**
