Matter was listed today for admission hearing.

Complainant prays for relief in terms of its Application accompanying original complaint. Complainant informs that in the matter vide Demand Notice dated 03.07.2024, an amount of Rs.16,39,238/- has been raised, which has further been added and raised as sundry in electricity bill dated 06.09.2024.

Complainant prays for stay on the operation of ibid demand Notice dated 03.07.2024 and sundry in bill dated 06.09.2024, pending final disposed of the complaint.

Complainant submits that it is willing to pay 1/3rd of the said amount of Rs. 16,39,238/- Counsel for Respondent is also present today who consents to the grant of Interim relief.

Complaint is admitted.

In terms of Regulation 25 of the HPERC (CGRF & Ombudsman) Regulations, 2013. Complainant is directed to deposit with Respondent HPSEBL ibid 1/3rd of Rs.16,39,238/- amounting to Rs. 5,46,413/- within a period of 10 days from this Order which is on or before 10th October,2024.

On deposit of the said 1/3rd amount of Rs. 5,46,413/- the Demand Notice dated 03.07.2024 and recovery of said sundry in bill dated 06/09/2024 shall be stayed and no coercive action shall be taken against the Complainant.

On non-deposit of the said 1/3rd amount of Rs. 5,46,413/- on or before the said date which is 10/10/2024, the Respondent HPSEBL shall be at liberty to take action as per extant Regulations/law, including disconnection.

On 23/10/2024, the Complainant shall place on record proof of deposit of the said 1/3rd amount of Rs. 5,46,413/-.

On aforesaid terms, Application is disposed of.

Main complaint is directed to come up for Reply on or before 23/10/2024.
