**Subject:- Regarding non recovery of outstanding amounts**

Er. Mandeep ji,

Your Immediate attention is invited towards the amount of Rs. **58,06,70,879/-** (Fifty eight crore six lakh seventy thousand eight hundred seventy nine only ) which is lying outstanding as on 31.12.2021 as per monthly return of Compilation Section(F&A Wing), HPSEB Ltd Shimla-4 in respect of your circle. From the perusal of return, it has been observed that sincere efforts have to be made by Sr. Xens/AE's of Divisions and Sub Divisions to recover the outstanding amount as the outstanding amount is very high. It is also to point out that due to non recovery of the outstanding amount the same is being increasing day by day from various consumers and the liability of H.P State Electricity Board Ltd is increasing continuously for purchase of power. The HP State Electricity Board Ltd is a commercial organization and can't afford such long time pendency of amount unrealized from consumers. Moreover in these days the financial position of HPSEB Ltd. is not sound and cannot afford huge amount of revenue unrecovered from various consumers.

Secondly you are also directed to take necessary steps to recover/realize the outstanding amount at the earliest. It may also be ensured that necessary precautionary measures be taken to avoid financial loss and to follow the rules / instructions of HPSEBL sales manuals **Instruction No 38 and Electricity Act 2003 to avoid consumers litigations by effecting TDCOs/PDCOs well in time.**

In case the recoveries of permanent defaulter the amount is required to be debited to the next kin of the premises after the final adjustment of ACD and other amount with HPSEBL and the action be taken as per the rules accordingly. In case the matter is under litigation in various Courts of HP the matter may immediately be taken up with the Advocates to file application of early hearing of case along with copy to this office. So far as the question of recovery of outstanding dues from Government Departments is concerned, the matter may be referred to the Head of the Department for early liquidation of arrears, simultaneously endorsing copies to the offices concerned for doing the needful in the matter immediately. Progress should be watched and reviewed fortnightly.

Being revenue matter the same may be assigned TOP PRIORITY as HPSEB Ltd is facing liquidity problem as this very one step of your office could be helpful for HPSEB Ltd to tide over the financial crisis.

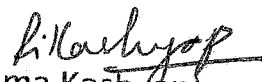
