In exercise of the power conferred under Articles-71 of the Articles of Association of HPSEB, Limited read with all other enabling provisions contained in Memorandum of Association and the Electricity Act, 2003, the Himachal Pradesh State Electricity Board Limited is pleased to make the following rules further to amend HPSEB **Junior Engineer (Electrical)/ Junior Engineer (IT) Class-III (Non Gazetted) Recruitment & Promotion Rules 2006** notified vide notification No. HPSEB (SECTT)/R&E/106-10/2006-93342-562 dated 13-12-2006 (**Annexure-A**), further amended from time to time vide Notification No. 71323-523 dated 9-10-2007, No.22792-991 dated 25-5-2010, No.76823-77023 dated 5-10-2011 and with latest amendment notified vide No. HPSEB (SECTT)/R&E/106-16/2010-99636-836 dated 13-12-2011 as under:-

1. Junior Engineer (Electrical).	
Existing provision against Column No. 7 Annexure-(A) regarding Educational qualification	Amended Provision
(I) Minimum Matriculation with Diploma in Electrical Engineering /Electrical & Electronic Engineering from a recognized Institution /Board /University duly recognized by the Central / State Govt. for JE (Elect) post.	Diploma or Degree in Electrical Engineering or Electrical & Electronic Engineering from a recognized Board/ Institution/ University, established by law by the State/Central Govt. OR AMIE from Institution of Engineers (India) (only those candidates who are enrolled for AMIE with the Institute of Engineer (India) Kolkata with permanent recognition upto 31.5.2013) would be eligible.
2. Junior Engineer (IT).	
Existing Provision.	Amended provision.
(1) Minimum matriculation with diploma in Computer Science Engineering or Electronic & Communication Engineering or Information Technology or equivalent from recognized institute/ University for JE (IT).	Diploma or Degree in Computer Science Engineering or Electronic & Communication Engineering or Information Technology from a recognized Board/ Institution/ University, established by law by the State /Central Govt. OR AMIE from Institution of Engineers (India) (only those candidates who are enrolled for AMIE with the Institute of Engineer (India) Kolkata with permanent recognition upto 31.5.2013) would be eligible.
* A Candidate shall be eligible for appointment to above posts if, he /she has passed Matriculation and 10+2, as the case may be from the School/Institution situated within Himachal Pradesh. Provided this condition shall not apply to Bonafide Himachalis.	

Existing provision against Column No. 11 Annexure-(A) regarding recruitment by Promotion.	Amended Provision
By promotion from amongst the following: (a) Surveyor matriculates and having ITI Certificate of Surveying from the recognized Institute with 5 years regular service as such. (b) Lineman/Electricians Matriculates and having ITI Certificates from recognized Institute with 7 years regular service as such. Total (a) +(b)= 22%. (c) Lineman/Electrician Matriculates (Non ITIs) having exceptional merit and aptitude with 12 years regular service as such. =5%. (d) Departmental employees holding three years Diploma in Electrical Engineering. =1% However, if eligible candidates are not available the 5% at (c) above would go to categories at (a) +(b) above. Note: (However, in case of non availability of eligible employees 1% quota at (d) above would go to (c) above.	By promotion from amongst the following: (a) No change. (b) Lineman/Electricians Matriculates and having ITI Certificates from recognized Institute with 5 years regular service as such. (Total (a)+(b)=22%. (c) No change. (d) No change.

These amendments will be applicable prospectively from the date of issue of notification.
