The seniority of the above named officers in the grade of Under Secretary will be fixed later-on.

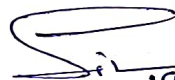

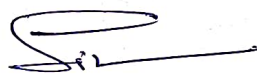
The above officers in whose case change of station is involved will be entitled to usual TTA /JT as admissible under the rules.
