The format on which these certificates are to be submitted is available on HPSEBL website i.e. [www.hpsebl.in/pension corner.html](http://www.hpsebl.in/pension%20corner.html) . It is mandatory for all the pensioners / family pensioners to submit these certificates to the pension Disbursing Agency before 15.12.2019. The detail of Pension disbursing agencies is as under:-
