1. Complaint has been filed by consumer bearing ID 100011001344 and listed today for the first time;
2. Complaint is accompanied with Application praying therein for Ad-Interim-Ex-Parte Stay on operation of Demand Notice dated 04.01.2025 (**Annexure C1**), where in monetary demand of Rs 9,89,425/- has been raised by the Respondent. Prayer has also been made for stay on operation of disconnection Notice dated 03.03.2025 (**Annexure C2**) also raised by the Respondent;
3. Counsel for Complainant present today submits that the Complainant is willing to deposit $\frac{1}{3}^{\text{rd}}$ of the disputed Rs 9,89,425/- amounting to Rs 329,808/- in accordance with the HPERC Regulations;
4. Complaint is admitted;
5. In accordance with regulation 25 of the HPERC (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, Complainant / Applicant is directed to deposit with the Respondent

the said $\frac{1}{3}^{\text{rd}}$ of the disputed Rs 9,89,425/- amounting to Rs 3,29,808/- within two (2) weeks' time from this Order i.e on or before 26.03.2025;

6. On deposit of the said $\frac{1}{3}^{\text{rd}}$ amounting to Rs 3,29,808/- operation of the said Notices dated 04.01.2025 (**Annexure C1**) and 03.03.2025 (**Annexure C2**) shall be stayed and no coercive action shall be taken by the Respondent till the disposal of the complaint;
7. On the next date, Complainant is directed to place on record proof of deposit of said $\frac{1}{3}^{\text{rd}}$ amounting to Rs 3,29,808/-;
8. On non-payment of the aforementioned monies amounting to Rs 3,29,808/- by 26.03.2025, the Respondent shall be at liberty to take action after 26.03.2025 as per extant law / regulations governing the power sector;
9. On aforesaid terms the Application is disposed;
10. Main complaint to come up for Reply on 28.03.2025;
