NOTIFICATION

In partial modification of this Department's Notification No. Per (AP-B)B(15)-11/2014 dated 17-04-2017, the Governor, Himachal Pradesh is pleased to order to discontinue/dispense with the process of evaluation of 15 Marks and to enhance the weightage of written test from 85 to 100 for Class-III posts/services under the State Government with immediate effect. The selection to all Class-III posts/services under the State Government shall be made on the basis of merit of written examination/Screening Test/ Skill Test.

2. For already notified vacancies by the Recruiting Authorities/ Agencies prescribing evaluation as prescribed vide Notification dated 17-04-2017, where written examination has not been conducted as yet, the posts shall be re-advertised by issuing supplementary advertisement immediately.

3. In case(s) where written examination has been conducted, the recruitment process shall be completed in accordance with the advertisement made viz a viz in consonance with the selection procedure already prescribed in the Advertisement and prevalent provisions of Recruitment and Promotion Rules mentioned therein.
