Terms and conditions:-

- 1) The Assistant Engineers (Electrical) appointed on contract basis will be paid consolidated fixed contractual amount @ ₹35940/- (₹ Thirty five thousand nine hundred and forty only) per month (which shall be equal to 60% of basic pay i.e. ₹ 59900 as per academic level 18 of the Pay Matrix of ₹59900-189800/-) or as revised from time to time. They shall not be entitled for any other allowances, whatsoever admissible to the regular employee of State Govt./HPSEBL from time to time.
- 2) The appointment shall be purely on contractual basis initially for a period of one year from the date of joining the post.
- 3) The age at the time of joining should neither be less than 18 years nor more than 45 years. Relaxation in upper age shall however be allowed in case of Scheduled Caste/ Scheduled Tribe/OBC and Ex-serviceman as per Rules.

- 4) The appointment shall further be subject to terms & conditions contained in the attached form of contract/agreement bond (Annexure) which is to be executed between the candidate and HPSEBL on stamp paper of worth ₹10/- only duly attested by the Executive Magistrate.
- 5) Contractual appointee Assistant Engineers (Electrical) will be required to submit declaration to the effect that he/she has only one living spouse, if married. In the event of having more than one living spouse, the appointment will be subject to his/her being exempted from the enforcement of the requirement in this behalf.
- 6) Contractual appointee Assistant Engineers (Electrical) are required to produce attested copies of academic and professional qualification certificate/Degree, Character certificate etc, along with Matriculation/Plus Two examination certificate in proof of his/her date of birth/age & qualification to the officer to whom he/she will report for joining the post.
- 7) He/She will have to produce a certificate from the competent authority in support of his/her belonging to SC/ST/OBC/EWS and Ex-Serviceman, in case he/she has been appointed against the vacancy reserved for these categories.
- 8) Contractual appointee Assistant Engineers (Electrical) will be required to take oath/affirm on the following form:-
I _____ do swear/solemnly affirm that I will be faithful and bear true allegiance to the Constitution of India as a by-laws established and that I shall carry out the duties of my office with loyalty, honestly, with impartiality and secrecy as required under 'official's secrets Act'.
- 9) The offer of appointment is subject to verification of Character and Antecedents report from the Competent Authority. If anything adverse is reported against the candidates, the appointment will be treated as null and void.
- 10) No travelling allowance will be allowed for joining the appointment/post.
- 11) Other conditions of service will be governed by the relevant Regulations/Rules and orders issued by the HPSEBL from time to time.
- 12) Contractual appointee Assistant Engineers (Electrical) will have to undergo on the job training.
- 13) The above appointments is subject to final outcome of following writ petitions:
a) CWP No.3400 of 2023 titled as Ms.Priksht Bharotha Versus HPPSC, Shimla & Another (Respondent No.3 i.e. Sh.Abhishek Kumar belongs to EWS category)
b) CWP No.2361 of 2022 titled Er. Vikas Raj & others vs. State of H.P. & another.

If, the above terms and conditions are acceptable, the above Contractual appointee AEs (Electrical) are required to report at HHPA, Fairlawns, SH 13, Dhalli, Shimla, Himachal Pradesh 171012 at 10.00 AM to undergo induction training w.e.f. 18.09.2023 to 30.09.2023, failing which, offer of appointment shall stands cancelled/withdrawn and no further correspondence shall be entertained in this behalf.

FORM OF CONTRACT AGREEMENT TO BE EXECUTED BETWEEN THE ASSISTANT ENGINEER (ELECTRICAL) AND THE H.P. STATE ELECTRICITY BOARD LTD.

This agreement is made on this ____ day of ____ in the year 2023 between Mr./Mrs./Ms. _____ (DOB _____) Son/Daughter of _____ resident of _____ contract appointee (hereinafter called the FIRST PARTY) and the H.P. State Electricity Board Ltd. (hereinafter called the SECOND PARTY).

WHEREAS, the SECOND PARTY has engaged the aforesaid FIRST PARTY and the FIRST PARTY has agreed to serve as Assistant Engineer (Electrical) on contract basis on the following terms and conditions:

1. That the FIRST PARTY shall remain in the service of the SECONID PARTY as _____ for a period of 1 year commencing on day of _____ and ending on the _____ day of _____. It is specifically mentioned and agreed upon both the parties that the contract of the FIRST PARTY with SECOND PARTY shall ipso-facto stand terminated on the last working day i.e. on _____ and information notice shall not be necessary.
2. Contract Appointee shall be paid consolidated fixed amount of @ ₹35940/- per month as prescribed by the HPSEBL from time to time. He/She shall not be entitled for any other allowance whatsoever admissible to the employees of State Govt./HPSEBL from time to time.
3. Contract Appointee so selected under these rules will not have any right to claim regularization or permanent absorption in HPSEB Ltd.
4. The appointment is liable to be terminated in case the performance/ conduct of the contract appointee is not found satisfactory.
5. Contract appointee will be entitled for one day casual leave after putting one month service and other leaves as admissible to contractual employee in H.P.Govt/HPSEBL. No leave of any other kind is admissible to the contract appointee. He/She shall not be entitled for Medical Reimbursement & LTC etc. only Maternity leave will be given as per rules.

6. Un-authorized absence from the duties without the approval of the controlling officer shall automatically lead to the termination of the contract. Contract appointee shall not be entitled for wages for the period of willful absence from duty.
7. Contract appointments will be made against vacant posts in difficult and tribal areas or the office jobs as per requirement. Transfer of contract appointee will not be permitted from one place to another. However, at the time of renewal of contract, if any, such appointee can be appointed at different place or office on administrative grounds,
8. Selected candidate will have to submit a certificate of his/her fitness from a Govt. Hospital, Women candidate, pregnant beyond 12 weeks will be considered temporarily unfit till the confinement is over. The women candidates will be re-examined for the fitness by an authorized Medical Officer of Govt. Hospital.
9. Contract appointee will be entitled to TA/DA, if required to go on tour in connection with his/her official's duties at the same rate as applicable to regular staff members.
