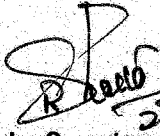
OFFICE ORDER NO. 24 HPSEBL (SECTT)/FTE-2/2025

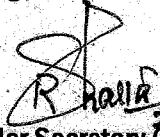
