**ORDER**

**WHEREAS**, the petitioner, namely Karan Singh, son of Sh. Jagdish Chand resident of Village & P.O. Tikkar Khatrian, Tehsil Tauni Devi, District Hamirpur, Himachal Pradesh, is presently posted as Assistant Engineer (Electrical) in the office of Thiro Power House Sub Division, District Lahaul-Spiti, a tribal station. He joined the said office on contract basis on 04.10.2023 and has been serving there continuously since then. Subsequently, his services were regularized at the same place of posting.

**AND WHEREAS**, the petitioner submitted a representation through the proper channel, which was received through the office of the Chief Engineer (Generation), HPSEBL, Sundernagar, vide Letter No. HPSEBL/CEG/2-3/2025-26-2054-55 dated 26.05.2026, requesting his transfer to a station nearer to his native place on the ground that he is required to look after his parents being old aged. However, before any decision could be taken on his representation, the petitioner filed a writ petition before the High Court of Himachal Pradesh, being CWP No. 10229 of 2026 titled *Karan Singh vs. HPSEBL & Ors.*

**AND WHEREAS**, the High Court of Himachal Pradesh vide judgment dated 25.06.2026 passed in *Karan Singh vs. HPSEBL & Ors* disposed of the writ petition with a direction to the competent authority to consider and decide the representation submitted by the petitioner within a period of eight weeks from the date of the judgment. The operative part of the judgment is reproduced below:

**“2. As prayed for, this writ petition is disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure-P-1, shall be decided by the competent authority, in light of the averments made therein within a period of 8 weeks from today, by passing a speaking order, in accordance with law.”**

**AND WHEREAS**, in compliance with the directions issued by the Hon'ble High Court of Himachal Pradesh, the representation dated 26.05.2026 submitted by Er. Karan Singh, AE(E), received through proper channel from the Chief Engineer (Generation), HPSEBL, Sundernagar vide Letter No. HPSEBL/CEG/2-3/2026-27-2054-55 dated 26.05.2026, has been examined and considered in detail in accordance with the applicable transfer policy, administrative exigencies, service requirements, and the facts and circumstances of the case. In the said representation, Er. Karan Singh requested his transfer after completion of tenure at tribal area to a station nearer to his native place on account that he is required to look after his parents being old aged and sought consideration for posting at any of the following stations:

1. ESD No.1, HPSEBL, Hamirpur
2. ESD Tauni Devi
3. ESD No.2 Hamirpur
4. ESD Barotiwala and
5. ESD Bhota.

In view of the above, the service particulars of the officers presently working in the aforesaid offices are placed below for kind perusal:

The feasibility of the stations requested by the officer has been examined in light of the availability of posts, tenure of the existing incumbents, and the provisions of the prevailing Transfer Policy of HPSEBL. The following position has emerged:

- ESD No. 1, Hamirpur:** The request for posting at this station has been found feasible.
- ESD No. 2, Hamirpur:** The request for posting at this station has not been found feasible at present due to the short stay of the existing incumbent.
- ESD Tauni Devi:** The request for posting at this station has not been found feasible due to the short stay of the existing incumbent. Moreover, the incumbent has already completed service in a tribal area.
- ESD Barotiwala:** The request for posting at this station is feasible on a vice versa basis, however, the matter is already under consideration through a separate transfer proposal of **Er. R. Vidur** placed on the departmental file.
- ESD Bhota:** The request for posting at this station has not been found feasible due to the short stay of the existing incumbent.

The service particulars and posting profile of **Er. Sunil Kumar, Assistant Engineer (Electrical)**, presently posted at **ESD No.1 Hamirpur**, have also been examined. Er. Sunil Kumar has been serving at ESD No.1 Hamirpur since 27.04.2023 and is available for adjustment against the vacancy that would arise at RE, Bhaba Power House Division, Bhabanagar.

**AND WHEREAS**, the representation dated 26.05.2026 submitted by Er. Karan Singh, AE(E), has been examined carefully in light of the facts and circumstances of the case, the grounds mentioned therein, his service record, the availability of suitable vacancies, the

administrative requirements of HPSEBL, and the directions issued by the Hon'ble High Court of Himachal Pradesh in CWP No. 10229 of 2026.

**AND WHEREAS**, after due consideration of all relevant aspects, it has been found that the request of Er. Karan Singh for transfer after completion of tenure at tribal area nearer to his native place can be accommodated at ESD No.1 Hamirpur through a vice-versa transfer arrangement with Er. Sunil Kumar, AE(E).

**NOW, THEREFORE**, in compliance with the judgment dated 25.06.2026 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 10229 of 2026 and after due consideration of the representation dated 26.05.2026 submitted by Er. Karan Singh, AE(E), the competent authority is pleased to order the transfer of Er. Karan Singh, AE(E), from Thiror Power House Sub Division, Keylong HPSEBL, Keylong District Lahul & Spiti to ESD No.1 Hamirpur vice Er. Sunil Kumar AE(E) and simultaneously transfer Er. Sunil Kumar, AE(E), from ESD No.1 Hamirpur to Thiror Power House Sub Division, Keylong HPSEBL, Keylong on a vice-versa basis. Er. Sunil Kumar shall be entitled to usual TTA & joining time as admissible under rules

Accordingly, the representation is disposed of accordingly in compliance with the judgment dated 25.06.2026 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 10229 of 2026.

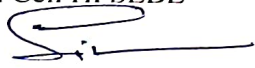
