Interim Order

(The previous date of hearing in the complaint was 20.12.2022).

Matter was listed today for admission hearing along with other matters. Ld. Counsel appeared after the completion of hearings around 1:45 p.m. and presented application for interim orders. The disconnection notice dated 29.12.2022 annexed with the application is sought to be stayed, as the complainant is willing to pay 1/3rd of the demand of Rs. 6,44,839/- raised by Respondent vide Notice dated 29.12.2022, which at the time of filing of Complaint was Rs. 6,24,854/- intimated to Complainant vide Respondent letter dated 03.12.2022.

Complaint is admitted. Forum directs the Complainant to pay the 1/3rd of Rs. 6,44,839/- amounting to Rs. 2,14,946/- within a period of 7 days from today, in view of its commitment as above and accordingly the demand notice dated 29.12.2022 is stayed. After deposit of ibid 1/3rd amount, 'Receipt' of deposit shall be placed on record immediately after the stipulated 7 days period along-with copy to Respondent HPSEBL. In case of failure to deposit 1/3rd amount within stipulated period of 7 days, the stay shall automatically stand vacated and

Respondent Board shall be at liberty to proceed against the Complainant qua the notice dated 29.12.2022 as per extant Rules/Regulations on the matter.

The Application for Interim Relief stand disposed of accordingly. The main complaint has already been fixed for Reply on or before 31.01.2023 along with advance copy to Complainant.
