The actual monetary benefits shall be regulated in accordance with the applicable rules, instructions and orders issued by HPSEB Ltd. from time to time.

The seniority of these officials in the grade of Supdt. Gr.-II shall be fixed later-on.

The officials in whose cases the change of station is involved will be entitled for usual TTA and joining time as admissible under the rules.

Consequent upon the above promotion, these officials should exercise their option with regard to date of increment/pay fixation under the provisions of HPSEBL Revised Pay Regulations, 2022 clause 8 (iv), within a period of one month.

This bears the approval of Competent Authority.

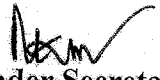
