OFFICE MEMORANDUM

In supersession of this department Office Memorandum of even number dated 07th September, 2022, the Government of Himachal Pradesh, after due consideration has decided to revise the grouping of posts on the basis of Level of Pay Matrix as notified in Schedule appended to the HP Civil Services (Revised Pay) Rules, 2022, as under:-

1. GROUP-A LEVEL 15 TO LEVEL 31
(₹10300-34800+5000 GP to ₹ 37400-67000+₹10000 GP)
2. GROUP-B LEVEL 12 TO LEVEL 15
(₹10300-34800+₹4200 to ₹10300-34800+4800 GP)
3. GROUP-C LEVEL 3 TO LEVEL 11
(₹5910-20200 + 1900 GP to ₹10300-34800+3800 GP)
4. GROUP-D LEVELS 1 & 2
(₹4900-10680 +1650 GP & ₹1800 GP)

2. The Gazetted status shall only be given to the posts falling in Group-A above. This issues with the prior concurrence of the Department of Personnel obtained vide Diary No. 56294925 dated 24.06.2025 on file No. Per(AP.B)B(15)-11/2020 Part-I dated 26.06.2025.
