Prayer Granted. The requirement of submission of Reply filed by the complainant in CWP 3704 of 2012 before the Hon'ble High Court is according waived.

Forum on perusal of record before it finds that the original case No. 1432/2024/09/31 and 14262028019 previously filed by parties in the matter have not been placed before it. Forum directs the Registry to tag/attach the complete original case files No.1432/2024/09/31 along with Complaint No.1426/208019 previously disposed by the Forum.
