ORDER

WHEREAS, the petitioner, **Er. Yash Pal, Assistant Engineer (Electrical)**, presently posted in the Office of Bhaba Electrical Sub-Division No. I, Katgaon under the RE Bhaba Power House Division Bhabanagar HPSEBL, District Kinnaur, filed **CWP No. 10538 of 2026**, titled *Er. Yash Pal vs. HPSEB Ltd. & another*, before the Hon'ble High Court of Himachal Pradesh seeking his transfer from the tribal area to a station of his choice or to a station near his native place.

AND WHEREAS, vide judgment dated **30.06.2026**, the Hon'ble High Court disposed of the writ petition with directions to the Competent Authority to consider and decide the petitioner's representation dated **29.04.2026** within six weeks and, if the petitioner had completed the normal tenure in the tribal area, to post him outside the tribal area at a suitable station of his choice, subject to administrative feasibility.

AND WHEREAS, in compliance with the aforesaid directions of the Hon'ble High Court, the representation of the petitioner has been examined in the light of the relevant records, the prevailing Transfer Policy, and the comments furnished by the concerned administrative authorities. It was found that the stations opted for by the officer were not feasible. Accordingly, Er. Yash Pal, AE(E), was requested vide this office letter No. HPSEBL (Sectt.)/GE/101-13/2026-23309 dated 15.07.2026 to furnish five additional choices of stations, covering more than one district. In response, Er. Yash Pal submitted his representation dated 17.07.2026.

It is observed from the records that the petitioner joined the Office of Bhaba Electrical Sub-Division No. I, Katgaon under the RE Bhaba Power House Division Bhabanagar HPSEBL, District Kinnaur on **18.09.2023** on contractual appointment and has been serving at the said tribal station continuously. His services were subsequently



regularized with effect from **01.10.2025** vide Office Order No. 56 dated **09.04.2026**. His present place of posting falls within the notified tribal area where the prescribed normal tenure is three summers and two winters.

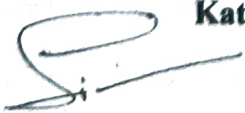
The competent administrative authority has confirmed that the petitioner has completed the prescribed normal tenure in the tribal area and is, therefore, eligible to be considered for transfer to a station of his choice in terms of the prevailing Transfer Policy, subject to administrative exigencies and availability of vacancy.

It has further been reported that Er. Bhushan Lal, Assistant Engineer (Electrical), presently posted at Electrical Sub-Division, Nither, District Kullu, is completing his prescribed normal tenure on 14.09.2026. Accordingly, upon completion of his normal tenure, the post at Electrical Sub-Division, Nither shall become available, and the adjustment of Er. Yash Pal against the said vacancy has been found administratively feasible.

The Competent Authority, after careful consideration of the judgment of the Hon'ble High Court, the petitioner's representation, the relevant records, the applicable Transfer Policy, and the administrative requirements of the Board, is satisfied that the request of the petitioner merits acceptance.

Accordingly, after due consideration of all relevant facts, records, and administrative requirements, the Competent Authority is satisfied that the petitioner's request deserves to be accepted.

NOW THEREFORE, The representation dated **29.04.2026** and even dated **17.7.2026**, stands disposed of accordingly in compliance with the judgment dated **30.06.2026** passed by the Hon'ble High Court of Himachal Pradesh in **CWP No. 10538 of 2026**. Accordingly, Er. Yash Pal, Assistant Engineer (Electrical), is hereby transferred from the Office of **Bhaba Electrical Sub-Division No. 1, Katgaon under the RE Bhaba Power House Division Bhabanagar HPSEBL**,



District Kinnaur to ESD Nither Distt. Kullu vice Er. Bhushan Lal, AE(Elect.) on vice versa basis. He will join on or after 15.9.2026 after completing Er. Bhushan Lal, AE(Elect.) normal tenure. Both will be entitled to the usual TTA/JT.
