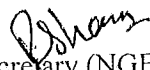

It is further intimated that these officials have availed first / 2nd and 3rd Chance to appear in the type test. This is for your information and the result of typing test may be conveyed to each individual please.

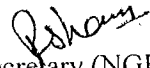

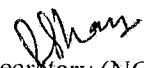
