In pursuance of the advertisement issued for the recruitment of Driver (Class-III) post on daily wages by HPSEBL vide advertisement No.1/2021 - dated 07-04-2021 and No.2 dated 8/11/2021 and further addendum issued vide No.HPSEBL(SECTT.)HRD/2-12(R/Ment)/ 2022- 70994-95 dated 14/01/2022 , on the recommendation of the Sub Regional Employment Officer Ex-Servicemen Employment Cell Himachal Pradesh at Hamirpur and Head Quarter Recruitment Committee constituted for this purpose to the post of Driver (Class-III post) on daily wages basis , the following 12 (Twelve ) candidates are hereby appointed as Driver (Class.-III post) purely on daily wages basis , falling in the share of Ex-serviceman quota, in accordance with the model roster notified by the Govt. of H.P. and further adopted by the HPSEBL against the sanctioned posts of Driver under EDs/Circles and CE office with their place of posting shown against each candidates as per the terms and conditions mentioned below, on the minimum wages @ of Rs. 411/- per day as fixed by the Gohp from time to time which was adopted by the HPSEBL as per R&P regulations notified by the HPSEBL.

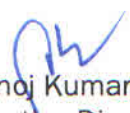


The above appointees are directed to report for duty in the respective Offices of their posting as shown against their name(s) within the prescribed time subject to the acceptance and fulfillment of the following specific terms and conditions:-

**TERMS AND CONDITIONS:-**

- 1) The appointment initially shall be purely on Daily wages basis. However, his/her services may be terminated by issuing of one month notice or payment of one month wages in lieu of notice, if his/her services are not required due to non-availability of work for which principle of first come last go shall be followed. His/her services may also be terminated in case his/her conduct and performance will not found satisfactory.
- 2) On consolidated monthly emoluments on the minimum wages @ of Rs.411/-per day. No other allowances shall be admissible.
- 3) He will entitled for male candidate 3 National Holidays with weekly rest i.e. Sunday and for female candidate 3 National Holidays with weekly rest i.e. Sunday and also 03 holiday i.e. Bhaiya Duj, Karwa Chauth and Raksha Bandhan as per notified by the Govt. of H.P. from time to time, no other kind of leave i.e. Casual leave/ earned leave will be admissible.
- 4) Subject to the production of original educational and other certificates for belonging to the reserved class etc. against which he/she is proposed to be appointed at the time of joining that these certificates have been issued by the competent authority in accordance with the instructions issued by the Govt. as well as HPSEBL from time to time.
- 5) He is liable to serve in any part of Tribal/difficult/backward areas of the State in which he may require to serve.
- 6) He should give a declaration that he/she has got only one living wife /husband or is bachelor.
- 7) He should produce a character certificate from the Magistrate 1st Class or a Gazetted Officer known to him/her for the last three years before he/she joins the above post.
- 8) He will furnish a declaration in writing that he/she has not been prescribed from the Govt. Service and he has not been dismissed from any institute under the Govt.
- 9) He will have to take an oath and undertaking in writing that he/she will not leak out any official information.
- 10) His appointment will be subject to the production of Medical Certificate of fitness from the concerned Chief Medical Officer of Government at the time of joining
- 11) Age should neither be less than 18 years not more than 45 years on 1st November, 2018. Upper age relaxable is also applicable to Ex-Serviceman candidates of H.P. as per provision of relevant rules / instruction of H.P. Govt.

- 12) He is required to produce all certificate viz qualification certificate with valid Driving license for light/heavy vehicle and practical experience of 2 years, discharge Slip, Ex-servicemen Certificate, Himachali Bonafide certificate, SC/ST/OBC etc. in support of his/her qualification, age and belonging to any reserved category at the time of joining the above post.
- 13) He be required to take an oath/affirm on the following form:-
- I \_\_\_\_\_do swear/solemnly affirm that I will be faithfully and bear true allegiance to the Constitution of India as by Law established and also I shall carry out my office duties with loyalty, honest and with impartially.
- 14) In case any of the certificates/information's produced/ given by the candidate is found false/wrong later on his/her services will be terminated.
- 15) Before accepting the joining report of candidates, academic /technical certificates submitted by the candidates/appointees shall be verified. At any stage if these are found invalid in HP the appointment order will be withdrawn without any notice.
- 16) The above appointments are subject to review due to any consequential administrative reason, that may arise later on.
- 17) In case he is willing to accept this offer of appointment on daily wages basis on the terms and conditions indicated above, they should report for duty at the station of his/her posting immediately, but not later than 30(Thirty) days from the date of issue of this offer, which in default the offer shall be automatically stand cancelled / withdrawn and the candidate will have no right to claim it and next candidate from the waiting panel shall be appointed.
