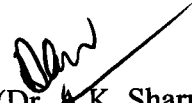

(ii) The officials appearing at Sr. No.23,43,49 & 58 shall join their new place of posting on or after 01.03.2020.

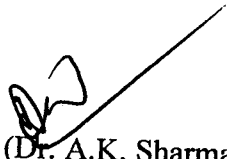
