OFFICE ORDER

WHEREAS, Er. Narender Thakur, Senior Executive Engineer (Electrical), HPSEBL was transferred from Electrical Division, HPSEBL, Rajgarh to the office of the Secretary, Himachal Pradesh Electricity Regulatory Commission (HPERC), Shimla vide Office Order No. 180 dated 27.11.2025;

AND WHEREAS, the aforesaid transfer order was challenged by Er. Narender Thakur before the Hon'ble High Court of Himachal Pradesh by way of Civil Writ Petition No. 18906 of 2025, inter alia, on the ground that posting on deputation/secondment to HPERC without his willingness is not permissible under law;

AND WHEREAS, the Hon'ble High Court of Himachal Pradesh vide order dated 01.12.2025 stayed the operation of the impugned transfer order and directed the respondents to file reply, which was duly filed by HPSEBL.

AND WHEREAS, the said Civil Writ Petition was listed for hearing before the Hon'ble High Court of Himachal Pradesh on **30.12.2025, 06.01.2026 and finally on 08.01.2026**, and upon hearing the parties, the Hon'ble Court passed the following order:

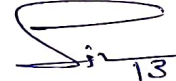
2. **When the matter was taken up today, learned counsel for respondents No.1 & 2-HPSEBL placed on record a communication dated 07.01.2026 conveying that two posts of Senior Executive Engineers are presently lying vacant at: (a) RE, Andhra Power House Division, Chirgaon, and (b) Electrical Division No.1, BVPCL, Jogindernagar. Learned counsel for the respondent-HPSEBL submitted that the petitioner can be accommodated at either of the above stations.**
3. **Learned counsel for the petitioner, on the basis of instructions imparted to her, submitted that the petitioner is ready and willing to be posted at RE, Andhra Power House Division, Chirgaon.**

4. Learned counsel for the respondents-HPSEBL submits that the necessary order for posting the petitioner at RE, Andhra Power House Division, Chirgaon shall be issued within five days, granting joining time to the petitioner, in accordance with law. 5. In view of above, the present petition stands disposed of. Respondents-HPSEBL shall act on the basis of the assurance given by them, as noted above. Pending miscellaneous application(s), if any, shall also stand disposed of.

NOW, THEREFORE, in compliance with the directions issued by the Hon'ble High Court of Himachal Pradesh in CWP No. 18906 of 2025 and after due consideration of all facts and circumstances of the case, Er. Narender Thakur, Senior Executive Engineer (Electrical), HPSEBL, is hereby ordered to be adjusted/posted in the office of RE, Andhra Power House Division, Chirgaon, against vacancy, with immediate effect.

This order is issued in strict compliance with the judicial directions of the Hon'ble High Court and in the interest of administrative exigencies.

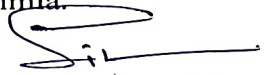
