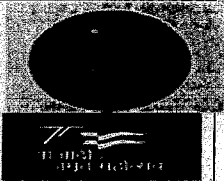

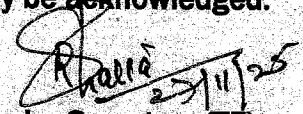
Sir,

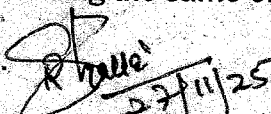
