Fuel and Power Purchase Adjustment Surcharge (FPPAS) for the month of March, 2025.

Sir/Ma'am,

Hon'ble HPERC vide notification No. HPERC-F(1)-67/2023 dated 29.11.2023 which has been published in Rajpatra, HP on 7.12.2023 has notified the HPERC(Multi Year Wheeling Tariff and Retail Supply Tariff), Regulations, 2023 which provides for levy of subject cited surcharge. HPERC in the tariff Order dated 15.03.2024 has also directed at Sl. No. 2.1.74 in this regard to levy FPPAS.

As per above regulations, the FPPAS for the month of March, 2025 has been calculated on the basis of Power Purchase Data received from the office of CE(SO) which works out to be on the positive side but total actual power purchase cost including transmission charges (April, 2024 to March, 2025) is on lesser side as compared to total Transmission charges approved by the HPERC for FY 2024-25.

Accordingly, FPPAS of **Rs. ZERO per unit** is to be billed to the consumers on energy consumption for the month of March, 2025 (Billed in April, 2025) with the energy bill of May, 2025 to be issued in June, 2025. The impact of FPPAS shall be as per clause No. 10.9.3 of Tariff Order dated 15.03.2024 and Hon'ble HPERC letters dated 31.08.2024, 03.09.2024, 20.09.2024 & 16.10.2024 and Himachal Pradesh Government's letter dated 28.08.2024 and 2 no. letter dated 18.09.2024.

The above instructions may be brought to the notice of all concerned for careful and meticulous compliance with immediate effect.
