Subject:- Business Reform Action Plan for States- Ease of Doing Business –Time frame for release of electric connection.

Sir,

Govt. of India has taken various initiatives for Ease of Doing Business in India. Department of Industrial Policy and Promotion, Govt. of India has made various recommendations to the States in respect of various areas and has recommended that the charged electrical connections up to 150 kVA is to be released within seven days (where no Right of Way(ROW) is required) and within fifteen days where ROW is required from concerned agencies.

In order to comply the recommendations by DIPPI, Govt. of India, competent authority of HPSEBL has approved following time frame for release of electrical connection:-

Sr. No.	Activity	Time Frame
		Release of connection From the date of completion of codal formalities and payment of all charges and security.
A)	For Contract demand up to 150 kVA (135 kW C/L) [Standard Supply voltage for load above 50 kW(kVA CD) is 11 kV]	
	a) Where no extension of distribution mains or commissioning of new sub-station/augmentation of sub-station is required and length of service wire is up to 30 mtrs.	7 days
	b) Where some minor works are required and location of the premises where connection is applied for is up to 200 mtrs from the distribution mains of required voltage level on which supply is to be released and there is no commissioning of new sub-station of sub-station is required and there is no right of way issue.	15 days
B)	Where extension of distribution mains or commissioning of new sub-station is required	As per Regulation 3 (3)- (b) & (c) of the HPERC (Licensee's Duty for Supply of Electricity) Regulations, 2004

Note:- In case the line for Sl. No. A(b) passes through/over the land /building/forest, the works shall be carried out as prescribed in rules framed by HP Govt. under section 67 of Act.

The concerned Chief Engineers (Op) shall ensure that tenders for execution of the works required to be executed for supply of power to the consumers , sub-division-wise should be done at the beginning of the financial year and it shall also be ensured that sufficient material is available with the field units as per load growth trend in order to adhere to above time frame.

All the instructions pertaining to above issued earlier and included in the Sales Manual stand superseded by this Sales Circular to the above extent wherever not in line with the above amendment.

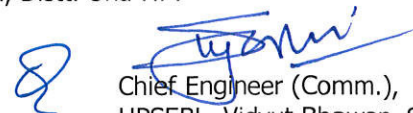
