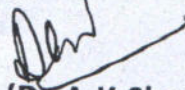

Now, the Himachal Pradesh State Electricity Board Limited is pleased to order that the emoluments payable to the employees working on contractual basis will be enhanced by an amount of 25% of grade pay making it equal to 150 percent of the grade pay of the post against which they have been appointed on contract basis.
