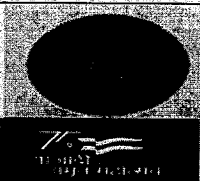

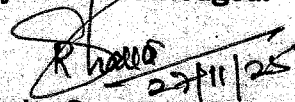
Sir,

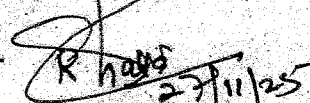
